On February 13, 2024, Sandisk Corporation ("Sandisk") issued an additional 29,863,251 shares of its common stock to Western Digital Corporation ("WDC"), its sole stockholder, such that WDC holds an aggregate 144,863,251 shares of Sandisk common stock. These additional shares were issued to WDC to facilitate WDC's distribution of 80.1% of Sandisk common stock to WDC stockholders of record as of February 12, 2025, in connection with WDC's previously announced spin-off of its flash business.
